COMMUNICATIONS:

Secretary reported recent insurance coverage renewal from Utica National Insurance (Policy Number: 1838688) includes an exclusion removing coverage from exposure to PFAs-"Per-and polyfluoroakyl substances. PFAs are synthetic chemicals that are used in aqueous film-forming foam (AFFF) to fight flammable liquid fires. PFAs are also known as "forever chemicals" because they don't breakdown in the environment.

Our current inventory (both onboard Engine 62 and in-rack storage of National Foams' "Universal GOLD 1%, 6% Alcohol Resistant Film-Forming Foam (AR-AFFF) contains per- and polyfluoroalkyl substance PFAs. PFAs are toxic chemicals that can contaminate water supplies and harm human health.

For these reasons, it is recommended that the District immediately begin a program to 1. Remove all inventory of current National Foam containing PFAs and 2.) Replenish inventory with replacement environmentally "Green" foam.
